

PROFESSIONAL ACTIVITIES ELIGIBLE FOR AWARDING SB-CEUs

The following professional activities are eligible for awarding SB-CEUs. These activities have been approved for the Fall, 2006 Semester.

New Teacher Mentor (07-146)

Criteria for Eligibility

- a. An assigned mentor to a new teacher must mentor for at least a full semester of an academic year.
- b. A new teacher mentor must submit to the building principal an evaluation of the performance activities for the application period.
- c. Three SB-CEUs may be earned for supervising a student teacher/teacher intern for a full placement period of not less than eight weeks.
- d. The signature of the building principal on the verification form will provide verification of the successful completion of the professional development assignment.

Supervision of School Psychologist Required Practicum/Interns (07-147)

Criteria for Eligibility

- a. Three SB-CEUs may be earned for supervising a school counselor/school psychologist for a full placement period as determined by the sponsoring college/university.
- b. A supervising counselor/psychologist must provide documentation of being assigned to serve as a supervising counselor/school psychologist to the building principal along with an evaluation of the performance activities for the application period.
- c. Three SB-CEUs may be earned for supervising a student teacher/teacher intern for a full placement period of not less than eight weeks.
- d. The signature of the building principal on the verification form will provide verification of the successful completion of the professional development assignment.

Supervision of Student Teacher/Teacher Intern (07-148)

Criteria for Eligibility

- a. A supervising teacher must supervise a student teacher/teacher intern for a university/college determined placement period of not less than eight weeks.
- b. A supervising teacher must prepare and submit to the building principal and/or the teacher preparation institution's representative an evaluation of the student teacher/teacher intern's performance.
- c. Three SB-CEUs may be earned for supervising a student teacher/teacher intern for a full placement period of not less than eight weeks.
- d. The signature of the building principal on the verification form will provide verification of the successful completion of the professional development assignment.

The following information must be received in order for SB-CEUs to be awarded:

- √ Participant Verification Form (one completed for each participant of each activity) attached;
- √ Copy of planned/completed activities for supervising/mentor teacher, school psychologist, school counselor.
- √ \$75.00 district fee per professional activity.
